Police – Bob Ludt, Chief:

For September 2016: 7 arrests, 24 citations, 191 reports, 218 security and welfare checks, 36 warnings, 10 crashes, 0 towed vehicles and 378 Trumbull 911 calls, 58 other police actions, 10 Donated hours. All officers have been attending mandated continuous training hosted by Girard. Read letter from Mike Lapmardo thanking Lt. Darbey for the professional and courteous manner in which he handled a recent incident at Mr. Lapmardo’s house. Vienna police provided protection for Donald Trump and Governor Pence again. Read letter from Trumbull County Engineer, Randy Smith, stating Niles Vienna will be closed October 23, 2016 to December 23, 2016. **(NOTE: Since meeting, this project has been delayed)**

Fire – Richard Brannon, Chief:

For September 2016: 82 total calls, 38 EMS calls, 4 vehicle accidents, 4 alarm drops (1 fire, 1 medical and 1 C.O. alarm), 1 fire (structure), 0 investigations, 1 burning complaint, 2 service calls (assist police with plane search and fuel spill), 3 wires/trees down, 9 public assists to residents, 14 mutual aid EMS, 1 mutual aid crash, 5 mutual aid fires, 23 ALS transports and 10 BLS transports; 1 mutual aid from Howland. Vehicle Maintenance: Engine 46 repaired water leak pipe pole bracket off ladder rack, replaced battery in the six wheeler. Fire station cascade system has been serviced along with fill station on rescue. Chief gave his opinion on the Marks system. Firefighter class is doing well, all air packs were bench tested. (air bottles are 12 years old), Rescue 46 will be at Baker Elementary School on October 8, 2016. Gas detector is being replaced with a newer model, which Dominion Gas is once again donating.

For September 2016 – 2 funerals, picked up electrical connectors for fire department, contacted Hayes for wiring light in township hall, assisted police in vandalism case, picked up drawings from architect for Mr. Dascenzo, replaced bulbs in meeting room and trustees' office, reported 2 street lights out, replaced smoke and heat sensors in township hall.

Mr. Pegg commented on ODOT signage at borders of township.

Carla Pacileo, Warren-Sharon: Spoke on behalf of the Mathews School Bond Committee, along with several other members, urging residents to vote for the school bond in the November election. The committee holds meetings at Mathews High School every other Wednesday to help answer questions and provide information about the bond.

Richard Miller, Youngstown-Kingsville: He feels more sections of the road on Warren-Sharon needed fixed after sewer project. The trustees will contact the Trumbull County Engineer.
